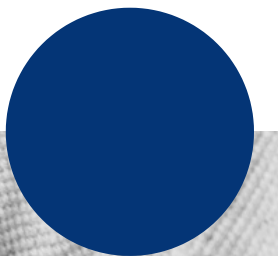




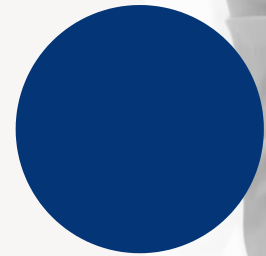

We have assisted many start-ups in leveraging artificial intelligence and research in order to:

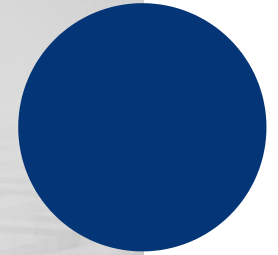

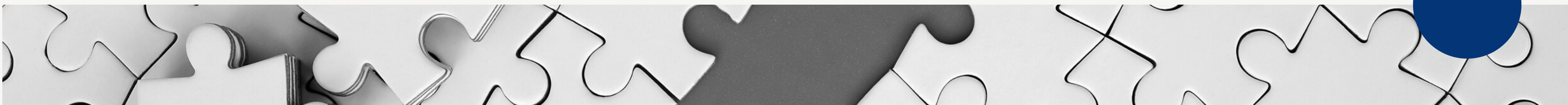

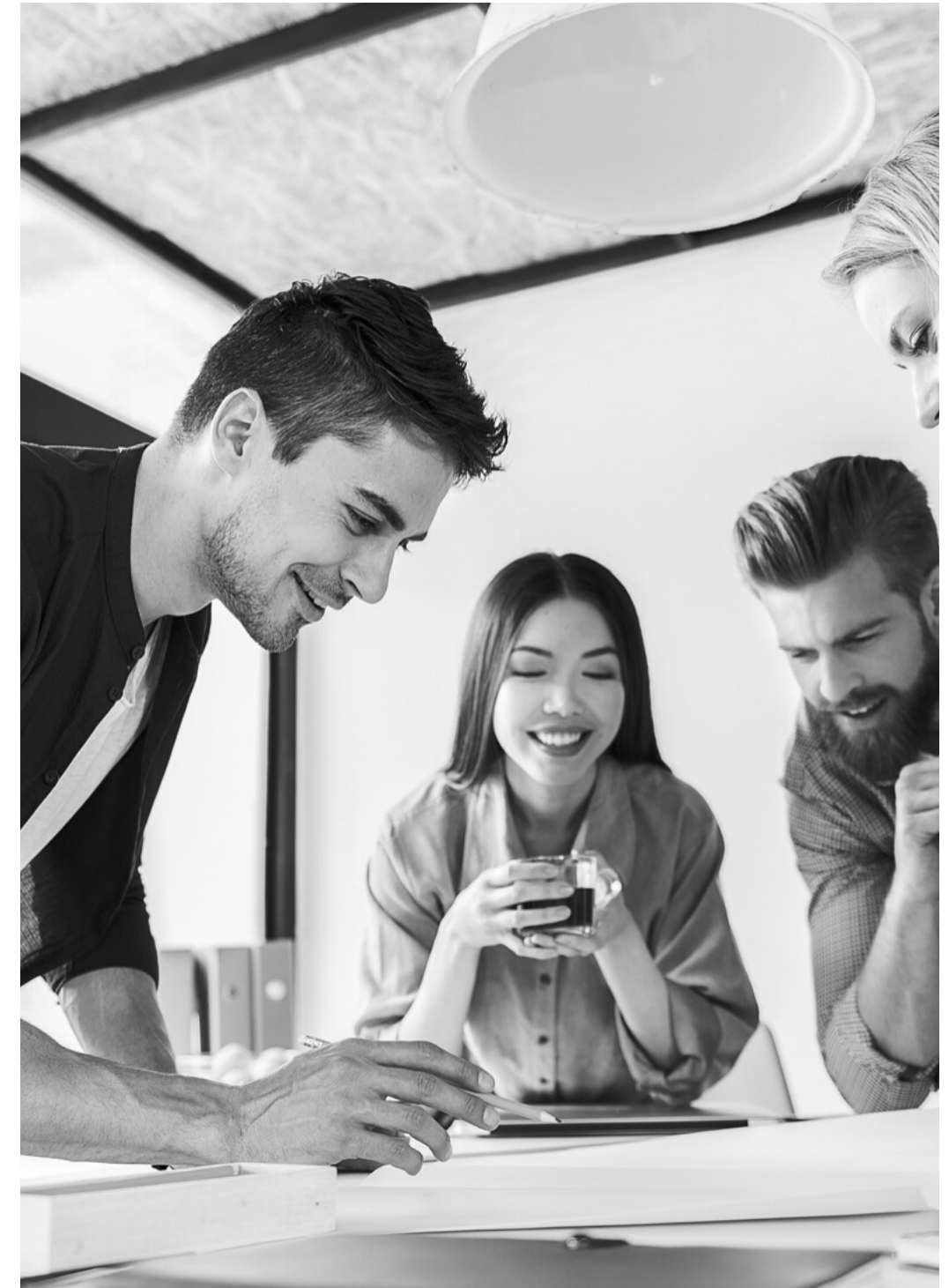
